Despite his education the PA states that he is most interested working in the food and beverage sector and he is interested in improving his language as well as getting experience working in the food and beverage industry to improve his employment prospects as many companies, including restaurants, require people who are fluent in English. PA has studied English at university and had sufficient level of English to work in a service industry position in the USA. PA has not provided a credible reason as to why he needs more ESL when he has already demonstrated that he has sufficient English to work in an English speaking environment; it would be strange that a Ukrainian employer would require a higher level of English ability than that. It appears that the PA may be using the ESL and work program to gain access to the Canadian labour market while circumventing the normal LMO process. I also note that the while the PA is enrolled at SEC the letter from his mother stating that she will provide financial support states that he will attend English Bay College. I suspect there is a hidden agent assisting the PA and providing form letters for submission. Overall, I am not satisfied that the PA's purpose is entirely as stated. Application refused.


